the condition of the above obligation is such that if the above bounden JAMES MORTON his heirs, executors, administrators shell and do well and truly pay and deliver or caused to be paid and delivered unto the above-named JOHN BRYAN, his heirs, executors, administrators or as signs all such sums or sums of money or other estate that shall come to his hands or possession as guardian of him, the said JOHN BRYAN, deducting they're out such reasonable sum as the orphans court for Kent County aforesaid shall allow for the said Guardians care and trouble in managing the estate of Sid JOHN BRYAN and that when the said JOHN BRYAN shall arrive at the age of 21 years or otherwise at such time as the said JAMES MORTON she'll be there until legally called then the above obligation is to be void or else to be and remain in full force and virtue.
