Sealed with our seals, and dated the 29th day of March in the year of our Lord one thousand eight hundred and eight.

The condition of this obligation is such, that if the above bound **ANDREW HERON, JOHN REEVES, WILLIAM REEVES** administrators of the good, chattels and credits of **ALLEN REEVES** deceased, do make, or cause to be made, a true and perfect inventory of all and singular the goods, chattels and credits of the said deceased, which have or shall come to the hands, or possession, or knowledge of the said **ANDREW HERON, JOHN REEVES, WILLIAM REEVES** or into the hands or possession of any other persons for them and the same so made do exhibit into the said court of ordinary at such time as they shall be hereunto required by the said court, and the same goods, chattels and credits do well and truly administer according to law, and make a just and true account of his actings and doings, where by law required, is all the said goods, chattels and credits which shall be found remaining upon account of the said administration the same be first allowed by the said court shall deliver & pay unto such persons respectively as one entitled to the same by law; & if it shall thereafter appear that any last will & testament was made by the said deceased & the said **ANDREW HERON, JOHN REEVES, WILLIAM REEVES** do in such case, if required render & deliver up the said letters of administration the this obligation to be void or else to remain in full force.
