To which payment will and truly to be made we bind ourselves and every of us, our and every of our heirs, executors and administrators for the whole and in the whole, jointly and severally, firmly by these presents, sealed with our seals and date the 15th day of February in the year of our Lord one thousand eight hundred and nine and in the 33rd year of American Independence.

The condition of this obligation is such that if the above bound **DEMSEY WINBOURN**, administrator of the goods, chattels and credits of **DEMPSEY WINBOURN**, deceased, do make or cause to be made a true and perfect inventory of all and singular the goods, chattels and credits of the said deceased, which have or shall come to the hands or possession or knowledge of the said administrator or into the hands or possession of any persons for them. And the same so made do exhibit into the said Court of Ordinary for York District at such time as they shall be thereunto required by the said court. And the same goods, chattels and credits do well and truly administer according to law. And make a just and true account of the actings and doings when by law required, then the above obligation to be void and of none effect.
