ITEM I give and bequeath unto my son **CHARLES** a cow and yearling and a two year old heifer.

ITEM I give unto my son **NATHANIEL** a cow and calf and a two year old and year old heifer.

ITEM I give and bequeath unto my son **WILLIAM** a cow and calf and yearling heifer.

ITEM I give and bequeath unto my daughter ANN a year old heifer ...

ITEM I give and bequeath unto my daughter SARAH a year old heifer ...

ITEM I give and bequeath unto my daughter HARDY a cow and calf and

ITEM I give and bequeath unto my son JOHN two sheep.

Lastly I give unto my loving wife all the rest of my personal estate making her my ... and ... only my land and plantation after her decease to my son **CHARLES**.
