First I give to my daughter **POLLEY PARHAM** one feather bed and furniture, one cow, one chest or box.

I give to my daughter **MILLEY PARHAM** one feather bed and furniture, one cow, one chest or box.

I give to my daughter **BETTY PARHAM** one feather bed and furniture, one cow, one chest or box.

The rest of my property I give to my loving wife MARY for her to possess as long as she liveth and after her death the land to be divided between RICHARD and FREDERICK PARHAM, that is to say I give to my loving wife MARY PARHAM all and singular my lands, messages, tenements by her freely to be possessed and enjoyed.

And I do hereby utterly disallow, revoke and disanull all and every other former testaments, wills, legacies, bequests and executors by me in any ways before named, willed and bequeathed, ratifying, confirming this and no other to be my last will and testament.

In Witness whereof I have hereunto set my hand and seal this fourth day of April in the year of our Lord one thousand eight hundred and six.

If anything left after her death LUCY, CHARLOTTE, POLLEY, MILLEY, BETTY is to divide it between them.
