I **JOHN O'BRIANT** considering the uncertainty of this mortal life and being of sound mind and memory, blessed be Almighty God for the same, do make and publish this my last will and testament in Manner and form following that is to say:

First after the settlement of all my just debts and the balance of my property, whatever real or personal, I give and bequeath to my beloved wife **SARAH O'BRIANT** during her widowhood or lifetime, should she remain a widow to be managed as she may think best until the youngest child becomes lawful age and then my property to be equally divided amongst my children and my beloved wife **SARAH O'BRIANT** to have a liberal support.

I hereby appoint my son **R. L. O'BRIANT** and **THOMAS LUTHER** executor to this my will and testament here by revoking any former Wills by me made and witness their of I have hereunto set my hand and seal this day of October in the year of Our Lord one thousand eighteen hundred and sixty five.
