Item I give to my son **BURRELL WOOD** two Shillings and Sixpence lawful money of North Carolina to him and his heirs forever.

Item I give to my son **PENUEL WOOD** two Shillings and Sixpence lawful money of North Carolina to him and his heirs forever.

Item I give and bequeath to my daughter **NANCEY TUCKER** Two Shillings and Sixpence lawful money of North Carolina to her and her heirs forever

Item I give to my daughter **DORCAS KIMBALL** half a crown to her and her heirs forever.
