PRINCIPAL and FIRST of all I recommend my soul into the hands of God that gave it, nothing doubting but I shall receive the same again at the general Resurrection by the mighty power of God, and as touching the for concerning such worldly a state where with it has pleased God to bless me in this life, agreeable, to contract with my husband, I give, leave and disposed of that same in the manner and form following.

IMPRINTS I leave and bequeath to my son ROBERT BRYANT one shilling sterling.

ITEM I give and leave to my son **WILLIAM BRYANT** one negro man named THOMAS only he must work in every year one month two or with my son-in-law **WILLIAM DEAN** or his heirs during life, and to my said son one black Heifer.

ITEM I leave to my daughter **NANCY DEAN** one negro when named ROSE and a cow and calf, and two beds and all other articles of house furniture to be divided between my said daughter **NANCY DEAN** and my son **WILLIAM BRYANT** as they may agree themselves.

ITEM I give and leave to my grandson FREDERICK WILLIAMS one black heifer.

ITEM I give and leave to my granddaughter SARAH THOMAS one churn.

And I appoint my heirs my executors, ratifying and confirming this to be my last will and testament sealed with my seal and dated the day and year first above written.
