This Indenture made this seventh day of May in y^e year of our Lord one thousand seven hundred and seventy two Between Levin Crapper of y^e County of Sussex on Delaware Esq^r of the one part and William Pointer of the same place yeoman of the other part Witnesseth that y^e said Levin Crapper for and in consideration of y^e sum of Twenty three Pounds good & lawfull money of this Government to him in hand paid by the said William Pointer the Receipt whereof is hereby acknowledged & himself therewith fully satisfied contented and paid from Every Part and Perch thereof doth fully clearly & absolutely acquit exonerate and Discharge y^e said William Pointer his Heirs & Assigns forever. Whith remised released and forever Quitted Claims by these Presents Doth remise release and for Ever quit Claim to the said William Pointer his Heirs and Assigns forever all that Tract or Perch of Land being Part of the said Described Premises viz Beginning at a corner of y^e above said Tract standing in said Pointer's fields & running from thence south Twenty seven Degrees East thirty two Perches and a half Landing Road thence with said Road south Eighty six degrees East Eighteen Perches North seventy five East Twenty six Perches North sixty nine Degrees East Twenty one Perches North thirty four degrees East forty two Perches North three Degrees East Twenty nine & a half Perches North Ten Degrees West thirty two and two Tenths Perches South sixty Three Degrees west one hundred Twenty three Perches & a half Perches to the Beginning containing forty six Acres & one hundred & four Perches of Land be y^e some more or less Together with all and singular the Improvements & Appurtenances thereunto Belonging To have and to Hold to y^e said William Pointer his heirs and Assigns forever all the above said forty six acres and one hundred and four Perches of Land with y^e Appurtenances and Improvements thereunto belonging free and clear from the Claim or Claims of him the said Levin Crapper and all and Every other Person or Persons claiming or to claim by from or under him the said Levin Crapper. Whith given granted bargained sold aliened Enfeoffed and confirmed and by these Presents Doth give grant bargain sell alien Enfeoff and confirm unto the said David Shankland his heirs Ex^r & adm^r and Assigns forever a certain perch of land containing about seven acres more or less being the North East end of thirty seven Acres of land formerly conveyed by a deed of sale from a certain Daniel Kling to Humphrey Turner of said County as appears by the said Deed bearing date the sixth day of February seventeen hundred & forty four To have and to Hold the said tenured seven acres of land Together with all woods ways easements hereditaments and Appurtenances whatsoever thereunto Belonging or in anywise Appurtenant unto y^e said David Shankland his heirs and Assigns to y^e only proper use and behoof of him the said David Shankland his heirs Ex^r & adm^r and Assigns forever to also all our right Title Interest and Claim of in and To the said tenured thirty seven Acres of land unto the said David Shankland his heirs and Assigns for Ever and the said Peter Adams and Mary his Wife for themselves heirs Ex^r & adm^r the said tenured land & premises unto the said David Shankland his heirs and Assigns forever against the lawfull Claims of the said Peter
