This Indenture made this first
day of November in the Year of Our Lord One Thousa
nd seven hundred and ninety three and of the Sov
erignty and Independence of the United States of
America the eighteenth between Samuel Bryant of
the County of Wilkes and State aforesaid of the one
part and Micajah Williamson Son of the County &
State aforesaid of the other part. Witnesseth that the
said Samuel Bryant for and in consideration of
the sum of three hundred Pounds Sterling to
him

him in hand paid by the said Micajah Williamson and
 the receipt whereof the said Samuel Bryant doth here
 by acknowledge hath granted bargained sold aliened
 and confirmed and by these presents doth grant
 bargain sell alien and confirm unto the said Mic-
 ajah Williamson his heirs and assigns forever all
 that tract and parcel of land containing one thousand
 and a few the boundaries and marks well more fully
 appear by reference to the plat annexed to the grant for
 said Samuel Bryant the grant bearing date the
 twenty fifth day of October seventeen hundred and
 ninety three and recorded in the office of the Secretary
 in Book W. W. W. fol 221 which is numbered as fol-
 low viz viz nine in a General Draft of eighty two Thousa-
 nd five hundred and twenty acres of land all of which
 lying and being in the County of Franklin in the
 State of Middle York of a certain Water in Continental
 Reserve together with all and singular the premises
 and appurtenances whatsoever to said tract or
 parcel of land belonging or in any manner appertaining
