Georgia This Indenture made the nineteenth day of July in the year of our Lord one thousand eight hundred & twenty between Stephen Brent of said state & county of Jackson of the one part & Daniel Kopp, John Stump & John Swiley all of the state of Tennessee County of Davidson of the other part Witnesseth that for & in consideration of the sum of fifty dollars now in hand paid by the said Daniel Kopp, John Stump & John Swiley before the signing & delivery of this present, the receipt whereof is hereby acknowledged, the said Stephen Brent have bargained & sold & conveyed by this present, unto the said Daniel Kopp, John Stump & John Swiley their heirs, maps & for ever all that tract or parcel of land containing by estimation forty square poles the same being part of six hundred & ninety acres of land originally granted to Zachariah Coft by him conveyed to Thomas Holdent by said Holdent conveyed to John Sundry by the said Sundry conveyed to Alexander Harper by the said Harper conveyed to the said Stephen Brent Beginning on said Bryant's north west corner and dogwood running from thence in a north east direction until intersected by a branch of the walnut fork known by the name of the Kiddy fork thence up the main and end of the said Kiddy fork on the south side thence of late the beginning To have the hold the said forty square poles with all & singular the rights & members, it appertaining, thence to belong to or in anywise appertaining to the said Daniel Kopp John Stump & John Swiley their heirs & assigns, for ever in fee simple In Witness whereof the said Stephen Brent have hereunto set by hand & affixed by seal the date above written
