Chains to a stake corner thence North forty five West ten Chains

to a red oak corner thence South forty five East twenty six

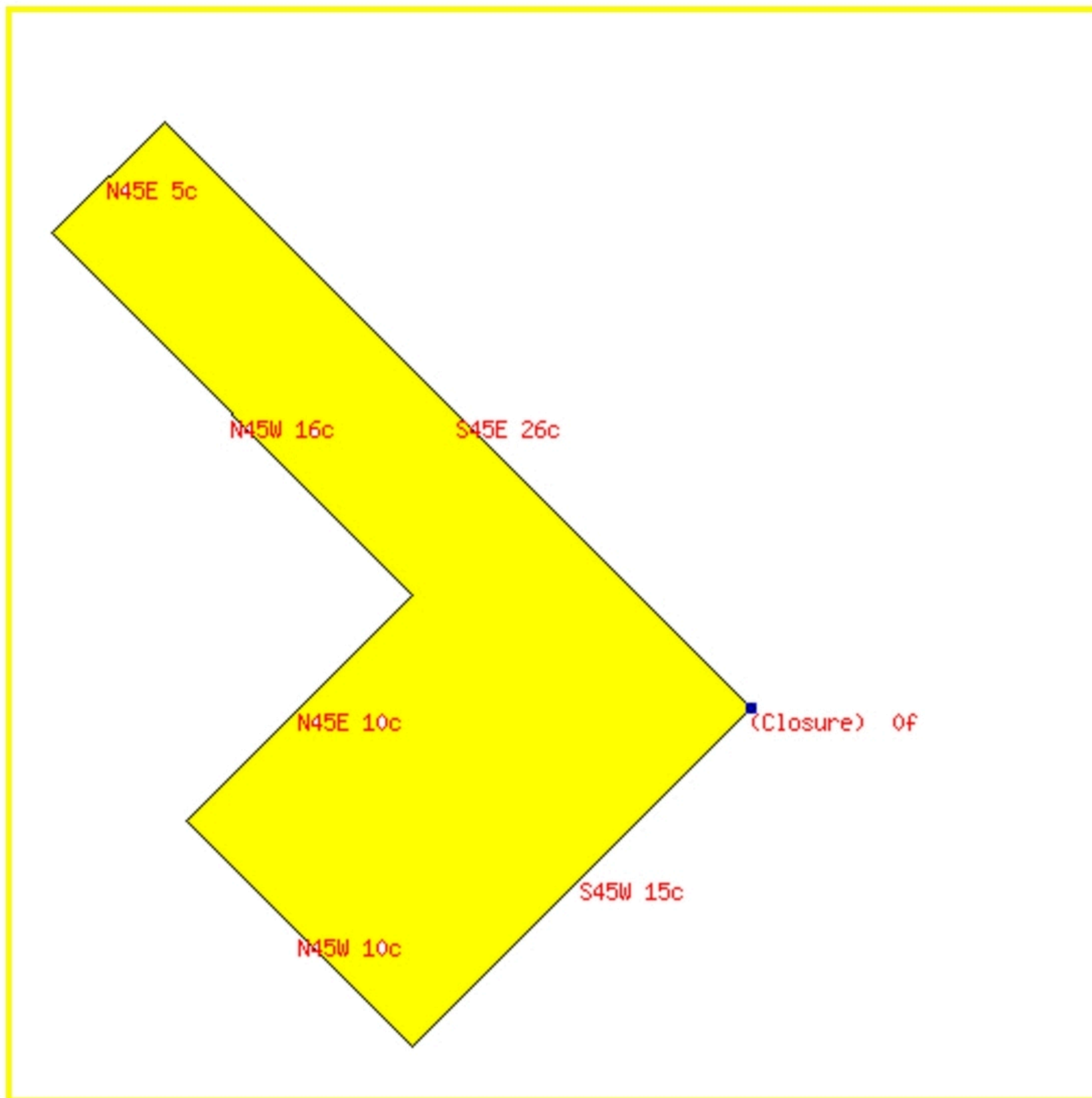
