This Indenture made
this fifth day of July in the year of our Lord
one thousand Eight hundred and nine between
Abraham Bryant of the county of Glynn and
State aforesaid of the one part and William
Collins of the county of Wayne and State
aforesaid of the other part witnesseth that
I the said Abraham Bryant for myself my

hires and assigns for? And in Consideration of the
sum of two hundred and fifty dollars to me in
hand paid by the said William Collins the
receipt whereof is hereby acknowledged by the
said Absalom Bryant have granted bargain
and sold and by these presents do grant bargain
and sell unto the said William Collins his
hires and assigns forever all that lot or tract of
Land containing two hundred two and an
half acres be the same more or less Drawn
by Temperance Bryant of the first district of
Wayne County in the late Land Lottery
which Lot or tract of Land is situate in the
nineteenth district of Baldwin County adjacent to
the flat and great and number one hundred
and twenty five and adjoining the follow-
ing Lots or tracts of Land to wit number one
hundred and sixty eight number one hundred and
ninety four and number one hundred and ninety six
and on the other side by the fifteenth district of
Baldwin County which will more fully appear by
the plat of the same as annexed to the grant
which grant was signed by his Excellency David Swain
Governor on the nineteenth day of April in the
year of Eighteen hundred and eight together with all
the woods water and Improvements thereon to have
and to hold the said Lot or tract of Land in
fee simple unto the said William Collins his
hires and assigns forever and I the said Absalom
Bryant do bind myself my hires assigns Execu-
tors and administrators to warrant and defend
the aforesaid tract or lot of Land Number one
hundred & twenty five in the nineteenth
district of Baldwin County from me my
hires assigns Executors & administrators I from
all & every other person or persons whatsoever
& from all & every kind of Claim

in Claims in whatsoever Manner they
may be to the end that the said William
Collins his heirs assigns Executors & administrators
may & shall enjoy the same free from
all manner of Encumbrances What
Ever Intertings of the said Absalom
Bryant have hereunto set my hand
