This Indenture made this twenty seventh day of October in the year of our lord one thousand seven hundred and eighty seven, and in the twelfth year of the Independance of the United States of America, Between William Bryant, and Martha his Wife of the county of Richmond, and State of Georgia, of the one part, and Mannum Beall, of the state and county aforesaid of the other part Witness that for an Inconsideration of the sum of ten pounds Sterling money of the said State, to them in hand, paid, at and before the sealing and Delivery of these presents, the Receipt whereof is hereby acknowledged. have granted, Bargained, sold, aliened, Released, and confirmed, unto the said Mannum Beall his heirs and assigns forever All that Tract or parcel of land containing Two Hundred, acres, Situate lying, and being, in the county of Richmond and State aforesaid Originally granted to the said William Bryant, on the sixth day of December, one thousand seven hundred, and seventy four Bounded at the time of survey Norwesterly, partly by lands of James Jackson, Sou easterly partly, by lands of Isaac Low and on all other sides by lands Vacant, Reference being had to the Original Grant Well more fully appear Together with all and singular the Rights Members and Appurtenances whatsoever to the said Tract of land being or belonging or in anywise appurtaining and the Remainders, Reversions Rents issues and profits thereof and Every part thereof To have and to Hold the said Tract of land and all and singular the premises, and appurtenances thereunto belonging as aforesaid and Every part thereof unto the said Mannum Beall his heirs and assigns to the only proper Use and behoof of the said Mannum Beall his heirs and assigns forever, and the said William Bryant and Martha his Wife for themselves and their heirs the Tract of land and premises, aforesaid and Every part thereof to the said Mannum Beall his heirs and assigns.




