Wm. May do hereby confess & acknowledge that I the sd. Wm. May have granted bargained sold aliened & confirmed & by these presents do freely absolutely & grant bargain sell alien & confirm unto the sd. James Gorden his heirs Exers. admrs. & forever a certain tract of lands containing one hundred & twenty three a cres & a half patent bearing date the 25th day of July A. D. 1775 being in the County aforesaid beginning & runs So. 80 Et. 447 poles thence No. 47 Wt. 158 poles to a pine thence So. 84 West 179 poles to the beginning it being the upper part of a survey of Wm. Mays on which the sd. James Gorden now lives TO HAVE & TO HOLD the sd. land & all & singular premises above mentioned unto the sd. James Gorden his heirs & assigns forever & I the sd. Wm. May myself my heirs & assigns that I the sd. Wm. May have good right power & lawful authority to grant bargain sell alien & convey the sd. tract of land & all & singular the above mentioned premises unto the sd. James Gorden & to only proper use & behoof of the sd. James Gorden his heirs & assigns forever according to the true intent & meaning of these presents & the same against me the sd. Wm. May my heirs & assigns or any other person or persons deriving or to derive by from or under them or any of them shall warrant & defend & also the sd. Wm. May my heirs & every other person or persons & his & their heirs anything having or claiming the above mentioned land & premises from or under me shall & execute all & every such further & lawfull act or acts thing or things device or devises conveyance or confirming & assuring the land unto the sd. James Gorden & to the only proper use & behoof of him his heirs & assigns as their coundil in law shall be reasonably advised devised or required IN WITNESS WHEREOF I have set my hand & affixed my seal this 11th day of Dec. 1775.
