

JEROM MILLER TO NICHOLAS NORCATT

Know all men by these presents that I Jerom Miller of the State of North Carolina and Anson County in consideration of the sum of two Hundred dollars to me in hand paid by Nicholas Norhil of the State of North Carolina and the County of Anson have Bargained sold and do by these presents grant Bargain sell unto the said Nichlas Norhil all that Tract of Land Lying and being in the County aforesaid on the waters of Lanes Creek and hath such courses forms and marks as a plat and grant granted to the aforesaid Jerom Miller dated January 25th. 1797 Doth Specify Viz. Beginning on a post oak a corner of Abram Millers corner & runing with said line So. 5 East 10 chains 50 links to a hickory So. 75 East 30 chains to a stake with a red oak pointer thence No. 10 Et. 34 chains to a stake on or near his own line thence No. 74 West 30 chains to a stake thence So. 15 West 24 chains to the Beginning containing one hundred acres together with all and singular the premises before mentioned unto the said Nichlos Norhil his heirs and assigns forever and I do hereby bind myself my heirs Executors and Administrators to warrant and forever Defend all and singular the said premises unto the said Nichlos Norhil his heirs and assigns against myself my heirs and against Every person whatsoever Lawfully claiming for the same or any part thereof In Witness hereof I assign my hand and affix my seal this 21st. of December and in the year of Our Lord 1799

ROBERT BRIANT TO JOHN MCONE

THIS INDENTURE Made this twenty seventh day of January in the year of Our Lord one thousand Seven Hundred and Ninety five Between Robert Briant of the County of Nash and State of North Carolina of the one part and Johnh McCone of the aforesaid State & County of Anson of the other part WITNESSETH that for and in consideration of the sum of Forty Pounds current money of this State to the said Robert Briant in hand paid by the said John McCone at or before the sealing and Delivery of these Presents the receipt and payment whereof is hereby acknowledged hath granted Bargained and sold aliened enfeoffed conveyed and confirmed unto the said John McCone his heirs and assigns forever one certain Tract or parcel of Land Situate in form and Manner as follows Viz. Being part of a tract of land granted to Zacariah Harrell in Anson County bearing date March 18th. 1789 Beginning James Harrells Jun. corner being the sixth corner in said plat & runs So. Ten West one hundred poles to a Black Jack the plant corner then North sixty five West Eighty poles to the patent corner then West one hundred and Twenty poles to the Beginning corner of the patent then With the patent line as it runs to a black

Jack Mills Harrells Dividing corner in the said plat then with Mills Harrells Dividing line to the Beginning Containing one hundred & fifty acres of land more or Less with the appurtenances Situate lying and being as aforesaid with their and every of their rights members and appurtenances whatsoever & the reversion and Reversions Remainder & remainders with all and singular the lands Tenements Hereditaments & premises hereby granted or intended to be granted and of Every part and parcel thereof & all rents Issues and Services and profits to them or any of them or any part or parcel of them of any of them Incident Belonging or appurtenant to them and also all & every of the Estate & right titles claims Interests and demands whatever him the said John McCone of or into the said lands tenements Hereditaments and premises whatever hereby granted or mentioned to be granted or any of them or any parcel of them to have and to hold the said lands tenements hereditaments and premises hereby granted with their appurtenances to the said John McCone his heirs and assigns forever and the said Robert Briant for himself his heirs Executors Administrators Doth hereby promise covenant and agree that he the said Robert Briant his heirs Executors and Admsr. shall and will at all times warrant and forever Defend the said premises to the said John McCone his heirs and assigns all lawful claims or Demands whatsoever whereby the above mentioned premises myight or may be affected or incumbered contrary to the true intent and meaning of these presents In Witness whereof the said Robert Briant hath hereunto set his hand and Seal the day and Date first above written
