Laurence O Bryan his heirs and assigns against the Lawfull Claim of all and all Manner of persons Shall Shall & Will Warrent & for E ver Defend by these presents & that the sd. Wm. Terry and his heirs & all & Every Manner of person or persons Whatsoever Lawfull Claiming by from or Under him them or Either of them at any time Or times hereafter Upon the Reasonable Request Cost & Charges in the Law of the sd. Laurence O Bryan his heirs and assigns Shall & Will Do Make Execute & Acknowledge Or Cause to be made Executed & Acknowledged all Such further & Other Reasonable Act or Acts Deed or Deeds Conveyance or Conveyances in the Law Whatsoever for the further & better Assuring Conveying and Confirming all & Singular the hereby Granted premises & Every part thereof With their Appurtenances Unto the sd. Laurence O Bryan his heirs & assigns as by him or them or by his or their Councel Learned in the Law Shall or May be Reasonably Devised Advised or Required in Witness Whereof the sd.
