

Thomas in the year Seventeen hundred and Eighty seven
Isom Onit of the County of Johnston & State of North Carolina
did make a Deed of Conveyance in full sample, to my John
Bryan of the County & State aforesaid, to a certain tract
or parcel of land Situate lying and being in the County
of Johnston & State of North Carolina, On the North side
of Kuse River, joining Tomlinsons line, Peter Browns
line, and Elisha Thomas Entry, Beginning at Thomas
Tomlinsons corner, and running along his line North fifty
five degrees West, one hundred and Eighty six poles to
his corner, then South twenty five degrees West Eighty six
poles to a Sassafras in the Edge of an old field, then
thirty poles to Browns line, then North four hundred
and twenty poles to a Black Oak, then East one hundred
and twenty poles to Cap^t Thomas line, then along his
line South ninety eight poles to his corner, then along
the other line East two hundred and twenty poles to a line
then South two hundred and thirty poles to the line of
Elisha Thomas's second Entry, then along said line West
one hundred and forty poles to his corner and then a
direct line to the first Station, containing Six hundred
and forty Acres more or less, Now know all men
by these presents that I the said John Bryan do hereby
release acquit and discharge the said Isom Onit
his Heirs and assigns from the Power and force of the
said deed of Conveyance to me the said John Bryan my
Heirs and assigns, and do for myself and my Heirs
acquit and discharge the said Isom Onit his Heirs
and assigns

186 and assigns from all debts dues, moneys and payments
of money to me and my heirs in consequence and Virtue of
the aforesaid deed of Conveyance to the within mentioned Tract
or parcel of land containing near hundred and forty ~~the~~
Acres more or less agreeable to the courses herein mentioned
and I do further for myself my heirs deny and relinquish
all and every Claim or demand in and unto the said Tract
of Land with its impertinances & advantages at this time or
any time hereafter In Witness whereof I have hereunto set
my hand and Seal, This Twenty eighth day of Decr.
1798

sold & by this presents doth grant bargain and sell
unto the said Thomas Leach a certain Tract or parcel
of Land lying situate being in the County of Johnston
State aforesaid on the south side of Middle Creek
