

This Indenture made August 21. 1809. Between Abraham Taylor, John Taylor, James Taylor, Wm. B. Taylor and Margaret Rowson ^{Rowson} William Rowson ^{Rowson}, all being heirs of John Taylor Second. and all of Mecklenburg County in North Carolina of the one part, & Thomas Boyd of P. place of the other part. Witnesseth that for the consideration of the sum of 220. Dollars in hand paid by the P. Thomas Boyd. the ac. whereof W^{ch} hereby acknowledge. and that W^{ch} the said Taylors — and Rowsons — hath granted bargained sold aliened enfeoffed conveyed and confirmed unto him the P. Thomas Boyd his heirs & assigns for ever a piece or parcel of land in P. County on the waters of Sugar Creek & Kings branch. being part of a tract granted to Margaret Donaldson by Henry & M^{rs} Elph by deed the 7th Jan^y 1767 and from P. Margaret D — n to Andrew Donaldson by deed the 11. April 1775 & from P. Andrew — to John Taylor by deed the 27th Feb^y 1780 — And the P. land being left to the P. Taylors — by the last will of P. John Taylor deceased. **BEING** at a pine on Dan Smiths line. then with said line N 22 E. 100 poles to a P. D. P. Smiths corner. then S 80 E 6 poles to a P. D. said Donaldsons old corner. then with the old line S 64 E. 132 pole to a P. D. — the old corner of P. land. then with P. Boyds line S 53 W. 04 poles to a Shemps at the great road near to Boyds house. and then with another of P. Boyds line to the beginning containing 55 acres. be it more or less. To have & to hold the P. granted land & premises with the appurtenances and all rights, privileges & improvements to the same belonging or appertaining to him the P. Thomas Boyd his heirs & assigns for ever. And W^{ch} the said Taylors — and Rowsons — for themselves, their heirs, exec^s and Admin^s hereby covenant & agree to & with the said Thomas Boyd, that he the P. Thomas Boyd his heirs & assigns shall for ever peaceably have hold occupy possess & enjoy the P. granted land & premises & every part thereof. And the P. Abraham Taylor Jr. Taylor. J^r. Taylor. W^{ms} B. Taylor and M^{rs} Rowson & Margaret Rowson doth Warrant and for ever defend the said land from all just & lawfull claims of all & every person or persons what ever. Joining & between Matthew Roberson W^m Parker, the heir of J^r. Bigham Dec^r. W^m Bigham the heirs of J^r. Taylor & Robert Bigham &c. **BEING** at a large P. D. Matthew Roberson corner and runs with his line N 75 E. 174 poles to a B. Jack, his corner. then N 35 E 37 poles to a W. O. W^m porters corner. then with his line and the heir of John Bigham N 11 W. 216 poles to a P. D. on the North west side of the Loring branch. said Bighams corner. then N 00 E. 100 poles then N 50 W. 104 poles to a W. O. on Parks old line. then S 5 E. 100 poles to a W. O.
