greeting, ~~that is to say~~ Mary Bryant and Benjamin
Bryant, both of the County of Anson and
State of North Carolina, for and in consider-
ation of the sum of Eighty pounds, current
money to us in hand paid at and
before the sealing and delivery of these
presents by Benajah Bryant of the same place
aforesaid, the receipt whereof we do hereby
acknowledge have bargained and sold
and by these presents do bargain and
sell, convey and confirm unto the said
Benajah Bryant his heirs and assigns
all our right title and claim to all the lands
lying on the South side of the Half Moon
Swamp, that was the property of Thomas
Bryant deceased, lying and being in the
County aforesaid and on the North side
of Deer River, joining Martin Hammonds and
Josiah Edwards lines and with the meanders
of said "Half Moon" branch and Sneed line,
containing by estimation two hundred
acres, be the same more or less. To
have and to hold all the said bargained
lands, with all and singular the
appertinances profits, benefits, arising or
may arise hereafter in any manner
whatsoever, and we the said Benajah

Bryant and Benjamin Bryant, our selves
 our heirs executors do covenant and agree to
 and with the said Benajah Bryant his heirs
 and executors that the said Benajah Bryant
 his heirs &c. shall have, hold, occupy, possess,
 and enjoy the said bargained land and pre-
 mises together with all houses, orchards, water
 and water courses thereunto belonging with-
 out let or molestation from our selves our heirs
 and executors forever, In Witness whereof we
 have interchangeably set our hands and seals
 the 5th day of September 1798.
