 by these presents and he the S^r John Davis hath
 granted bargained sold alienated and confirmed and by
 these presents doth grant bargain sell alien and confirm
 unto the S^r John Briant and his heirs a certain tract
 or parcel of land lying and being in the County and State of
 on the South side of Main broad river beginning at a white oak
 thence East one hundred and twenty seven poles to a Stake
 thence South one hundred and twenty seven poles to a Stake
 thence west one hundred and twenty seven poles to a Stake
 thence North one hundred and twenty seven poles to the
 Beginning containing one hundred Acres of land and all
 houses ways profits thereof and also all the Estate with
 title Interest use trust claim and demands what so ever
 of him the S^r John Davis of and to the S^r John Davis
 to have and to hold the S^r land hereby conveyed and all
 and singular the premises hereby bargained unto the
 S^r John Briant and his heirs and assigns forever
 And the S^r John Davis for himself his heirs &c;
 and assigns doth covenant promise and grant to and
 with the S^r John Briant his heirs and assigns by
 these presents that the S^r John Davis now at the
 time of sealing and delivering of these presents is
 seized of a good sure Estate of Inheritance in fee
 Simple of and in the premises hereby bargained
 and sold so that he hath good power to grant

to grant and convey the same to the S^r John Briant in Man-
ner and form aforesaid; and that the S^r John Ravis shall
guarantee and his heirs all and singular the premises here-
bargained and sold with the Appurtenances unto the
S^r John Briant and his heirs and assigns against
him the S^r John Ravis and his heirs and assigns all and
every other person or persons whatsoever shall warrant
