

Together with all and singular the Rights and Members, Tenements, Hereditaments, and Appurtenances to the said premises incident or in anywise appertaining. To Have And To Hold all and singular the premises before mentioned unto the said Collier and Talbert their Heirs and Assigns for ever. And I do hereby bind myself and my Heirs, Executors & Administrators to warrant and for ever defend all and singular the Premises before mentioned, unto the said Collier and Talbert their Heirs or Assigns against myself or my Heirs or against the lawful claims of all persons whomsoever. ation of two hundred Dollars to me paid by Charles C. Woods of Pendleton  
District and State aforesaid (Farmer) have Granted bargained sold and rele  
ased and by these presents do grant bargain sell and release unto the said Charles C. Woods all that  
tract or parcel of Land containing fifty acres be the same more or less, laid out near the middle of a  
227 1/4 acre tract of land originally surveyed by Samuel H. Dickson D.S. for Benjamin Brimer the 17th of  
June 1791, and granted the 4th of July the same year lying in Pendleton District on a North Branch of  
Mountain Creek a branch of Big Generostee waters of Savannah River. Viz. Beginning on a R. 0.3. o.m. 3x2. m.  
Thence S. 35. E. 11: 80 to Stake. Thence N. 55. E. 19. to Stake n. Thence S. 18 1/2 E. 18: 10 to St. on the old line. Then  
due W. 19: 60. to Stake 08: 2. Thence S. 10. W. 13: 38. to Stake o.m. Thence N. 60: 2 W. 16: 65. to P.O. 3x. a.m. Thence N. 20:  
E. 22: 65 to the beginning R.O. corner. Binding North on Hammons' es land. East and South on Joseph  
Brimer's land. South-west on David Yates land. West on Thomas Burris' es land. as will more fully appear  
by a plat hereunto annexed of a resurvey made by Major Lewis D.S. the 9th day of September 1820, wherein  
Matthew Gentry now lives. Together with all and singular the Rights Members Hereditaments and  
Appurtenances to the said premises belonging or in anywise incident or appertaining. To Have



Dickson D.S. for Benjamin Brimer the 17th of June 1791 and granted the 4th of July the same year. In Pendleton District on a North branch of Mountain Creek a Branch of Big Generostee, waters of Savanah River, and hath such shape form & marks as the above Plat represents.

Wood His Heirs and Assigns all her interest and estate also all her right & claim of Power of in or to all and singular the premises within mentioned and released. Know all men by these presents that I Joel Breazeale of Pendleton District in consideration of the sum of three hundred Dollars paid me by Kennon Breazeale of State and District aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Kennon Breazeale that tract of Land whereon I now live containing one hundred and thirty seven acres more or less being part of a tract of 402 acres granted to Reuben Clemons by his Excellency William Moultrie on the seventh day of January 1793, and recorded in Secretary's Office in grant Book F. No. 5. Page 430. and conveyed from said Reuben Clemons to me Beginning on a Maple 3.x. on big Rock creek running thence S. 64. E. 25:50 to a small Red-oak 3.x. Then S. 39. W. 43. to a Stake 3.x. Thence N. 33. W 19:20 to a Stake 3.x. thence S. 62. W. 14:50 to a Maple 3.x. on a small branch. Thence N. 59. W. 13:60. down the meanders of the Branch to a large Black-oak 3.x. Thence N. 53. E. 9. to a small Post-oak 3x on the Keowee Road. Thence N. 33. W. along the Keowee Road (crossing Rocky Creek) 19. to a Post-oak 3x. Thence N. 53. E. 5. 30 to a Black-oak on a Branch Thence S. 76. E. 15 along a conditional line to a Poplar 3x on said Rock Creek thence up the meanders of said Creek to the beginning. Together with all and singular the Rights Members Hereditaments and Appurtenances to the said Premises belonging or in any wise incident or appertaining. 
