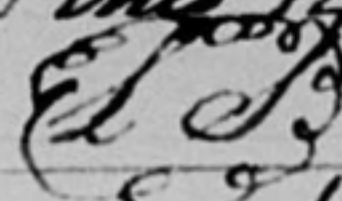

Know all men by these presents that I Nancy O'Briant, and State aforesaid in consideration of the of Fifty Dollars to me in hand paid by Lewis Morris of the District & State aforesaid hath granted bargained sold and by these presents do grant bargain and sell one plantation or tract of land granted to George O'Briant and by him willed to Timpy Starn during her life time then to P^r Nancy O'Briant containing one hundred Acres more or less on the Waters of Brushy fork of Sandy River the Shape and Courses Not known Together with all and Singular the Writs, Members hereditaments and Appurtenances to the P^r premises belonging or in any wise Incident To have and to hold Unto the Said Lewis Morris his heirs executors and Administrators or assigns forever And I do hereby bind myself my heirs executors and Administrators or assigns to Warrant and forever defend all and Singular the Writs, Members hereditaments to the Said premises unto the Said Lewis Morris his heirs executors and assigns forever Against myself my heirs and assigns and Against every person or persons whomsoever lawfully claiming the same or any part thereof In Witness whereof I have set my hand and affixed my Seal this twenty first day of Sept in the Year of our Lord one thousand Eight Hundred and eighteen And in the Forty Second year of America Independence
