day of January in the year of Our Lord. One thousand seven hun-
-dred and Ninety three and in the Seventeenth year of North
American Independence Between Stephen Crocker of
Darlington County in the State of South Carolina Planter
of the one Part & William Brian of the same place (Planter)
of the other Part. Witnesseth, that the said Stephen Crocker for
and in consideration of the sum of forty ~~Pounds~~ Sterling money to
him in hand paid by the said William Brian at or before the
Sealing and delivery of these Presents doth bargain, Sell, Alien,
Engage, Convey and Confirm unto the said William Brian &
to his heirs & assigns forever a certain plantation or Tract of
Land containing one Hundred & fifty acres, be the same more or less
Situated lying & being in the County of Darlington and State aforesaid
Situate on Palmeto Swamp Granted to David Lee the tenth day of
April Seventeen hundred & Seventy four and conveyed by him
to William Crocker the fourteenth & fifteenth days of February
Seventeen hundred & Seventy three and descending from the said
William Crocker who is now deceased by heirship unto Benj^a
Crocker who is also now deceased, and descending from said
Benjamin Crocker by heirship unto Benjamin Crocker, who is
also now deceased and descending from said Benjamin Crocker
by heirship unto the above named Stephen Crocker and by these
Presents conveyed by the said Stephen Crocker unto the above
said William Brian bounding Southwest on William Baxters
Land South East on Daniel Polk's Land. other sides vacant when sur-

of Persons whomsoever claiming or that hereafter may claim the
