same State and County, Witnesseth that the said Jesse Havis &
Mary his wife in Consideration of the Sum of twenty five pounds
sterling, have granted bargained sold aliened remised released and
confirmed and by these presents do grant bargain sell alien
remise release and confirm unto the said John Johnston in his
actual possession now being by virtue of a bargain and sale
to him thereof made for one whole, by Indenture of lease bearing
date the day next before the day of the date of these presents and
by force of the Statute for transferring uses into possession and
his heirs and assigns all that plantation or tract of land con-
taining fifty two acres more or less granted to the said Jesse Havis
on the sixth day of May Anno Domini 1793, by Wm Moultrie
Esq: Governor then — Which said plantation or tract of land is
situate in the District of Camden and County aforesaid bounded
by lines running NW. & W. by Wm Johnston NW. by Daniel
wrens and hath such shape form and marks as is represented
by a plat to the original Grant annexed reference thereunto shall
more fully appear Together with all and singular the
