

This Indenture made this 18th day of August in the year of our lord one thousand Eight hundred and fourteen between Jacob Hytle of the state of south Carolina and Greenville District of the one part and Charles Gosnell of the state and district aforesaid of the other part Witnesseth that I Jacob Hytle for and in consideration of the sum of one hundred dollars to him in hand paid by the said Charles Gosnell Witnesseth that the sd Jacob Hytle of the State and district aforesaid hath granted bargained sold and delivered and by these presents doth grant bargain sell and deliver unto the sd Charles Gosnell a certain tract or parcel of land situate lying and being in the State and district aforesaid and on the branches of South Pacolata Beginning at a hickory thence N^o 20 E 35- 50 links to a chestnut thence N^o 61 E 8- 50 links to dogwood thence N 25 W. 25- 50 links to a red oak thence N^o 10 W 39- 50 links to a hickory thence S^o 20 W 26 to a red oak thence S^o 25 E 20 Spanish oak thence S^o 30 W 32 to a red oak thence an offset of about 5 chains more a south east course to a chestnut thence S^o 82 E 15 to a locus thence S^o 80 E 29- 30 to the beginning hickory corner containing two hundred and eighty acres be the same more or less with all and singular the rights and promises to the same ^{belonging} to have and to hold unto the said Charles Gosnell his heirs and assigns forever and the said Jacob Hytle doth hereby bind myself my heirs and assigns to warrant and forever defend all and singular the rights and promises unto the said Charles Gosnell his heirs and assigns against myself my heirs and assigns and from all and every person or persons what soever lawfully claiming the same or any part thereof.
