singular the said premises unto the said Henry M Kelvey his heirs and assigns against myself my heirs and every person or

Laurens District in the year of our Lord one thousand Eight hundred & twenty: between Willis Robertson of
the District & State aforesaid of the one part and Jesse Fuller of District & State aforesaid of the other part, Witnesseth that the
said Willis Robertson for and in consideration of the sum of twenty dollars to be paid by the said Jesse Fuller in pursuance of
the Covenant & agreement of the said Jesse Fuller, hereinafter contained doth for himself & his heirs & assigns covenant and agree with
the said Jesse Fuller that he the said Willis Robertson or his heirs, do convey all his right title, interest or claim of any or all of the
property of Absalom Coleman dec'd of which of which he is now or hereafter may be entitled to in right of his wife Elizabeth Rob-
ertson formerly Elizabeth Coleman, It being for the valuable consideration of the sum of twenty dollars which I the said Willis
Robertson do acknowledge to have received from Jesse Fuller for all the undivided interest, that I the said Willis Robertson and Justly
entitled in right of my wife Elizabeth in the Estate of Absalom Coleman, dec'd, In testimony whereof the parties have hereunto inter-
changeably set their hands Seals the day & year just above written
