July 15, 1784 Rev. Stith Parham of Sussex Co., being fully persuaded that freedom is the natural right of mankind, emancipates negroes.

Oct 8, 1791, Stith Parham, Sr. to his son Matthew Anderson Parham. Deed of Gift: The following Negroes: Roger, Tom, Sarah, Sucy and Scott.

Sussex Co., VA Will Book E, pg. 222 Will of Stith Parham Jun 5, 1793, proved Sep 5, 1793 Son Stith Parham my slaves now in his possession and other property that I have in SC. Son Matthew Anderson Parham slaves now in his possession and the rest of my Estate in VA. Granddaughter Elizabeth Parham daughter of Stith Parham. Ex: Son Matthew Andersom Parham. Wit: William Massenburg, William Wynne and Thomas Eldridge.

Will of Isham Parham dated Oct 1792, proved May Court 1807 Isham names Wife Elizabeth; sons, Thomas, Isham, John, Samuel, George, each about 83 acres; the Cumberland land sold to pay debts owed.

Executers None, Thomas B. Littlejohn appointed Administrator, Witnesses; son John Parham,

Samuel Hayes and Joshua Hutchinson.

"Isham Parham died Apr 6, 1807, his son made a crop on land with the help of Negroes of Isham dec'd and with assistance of brother in law Samuel Peace. Dec 11, 1807 sale of personal estate of Isham Parham dec'd, by Thomas Littlejohn, Adm. Items brought by Thomas, Samuel, and Isham Jr. and others. Wife Elizabeth.
