aforesaid attorney is further authorized to
sell our respective shares of tunc, or
other incidental expenses and also to give
receipts for the payment of money as our

fifty six dollars and fifty four cents to
him in hand paid by the said Abner Franklin

the said Abner Franklin a negro woman
named Jane and her children William
Jena Henry and an infant not named
and their increase and the said John H.
McLaughlin for himself and his heirs
