& Eighty eight 1788 I Mary Davis of Cedar Creek Hundred Sussex County in the Delaware State Relict and Widow of
Samuel Davis late of the same place dec^d. being sick and weak of body but of perfect mind and memory thanks be
to God for his mercy, and calling to mind the Mortality of my body & that it is appointed for all the human race
once to die, Do make, Ordain and Constitute this and no other to be my Last Will and Testament.

I impudicis I give and recommend my soul into the hands of God who gave it me, & as to my body Please it to be buried
in a decent like Christian manner, at the discretion of my Executors nothing doubting but at the General Resurrection I
shall receive the same again by the mighty power of God, and as touching such worldly goods wherewith it hath
pleased God to bless me in this life I give bequeath & dispose of the same after the following manner and form

Item. I give and bequeath to my son Isaac Davis One Shilling and no more.

Item. I give and bequeath to my son William Davis One Shilling and no more.

Item I give and bequeath to my daughter Nancy Davis One feather Bed & furniture also one Pewter dish &
one Pewter plate, likewise three Silver Tea Spoons.

Item I give & bequeath to my daughter Elizabeth Davis (who I constitute to be sole Executrix of this my Last Will &
testament) all & singular the residue and remainder [that I have not mentioned] of my Estate to her her heirs & assigns
And I do hereby, disannul & revoke all former Wills & Testaments whatsoever ratifying & Confirming this and no
other to be my Last Will and Testament. In Testimony whereof I have hereunto set my hand & Seal in the presence

Memorandum the 20th day of December 1788 before me Phillips Kollock Register
appointed for the Probate of Wills and granting Letters of Administration for the County aforesaid appeared Ratcliff
Poynter and Shadrack Slurgis, two of the witnesses to the within Will, who being sworn on the Holy Evangelists of
Almighty God did severally depose and say that in their sight & presence and hearing the Testatrix Mary Davis
did sign, Seal, Publish and declare the same to be her Last Will and Testament, and that at the doing
whereof she was of a sound and perfect mind memory and Judgment, and that they and each of them together
with Shadrack Slurgis, subscribed the same as witness in presence of the Testatrix and at her request

mind and sound memory, and calling to mind that it is appointed for all men once to die Do make and ordain this
my Last Will and Testament in manner and form following that is to say First I command my soul to God that
it me, and my body I commit to the earth to be buried in a decent manner at the discretion of my Executors hereafter
mentioned and named, and as touching my worldly Estates it hath pleased God to bless me with, I give and dispense
thereof as followeth.
