In the Name of God amen the Eighth day of April one thousand seven hundred and twenty three I John Robinson of the County of Granville & Province of North Carolina Being Sick & Weak of body yet in perfect Sense & Memory thanks be to God for the same Do Make Constitute Ordain & Declare this to be my last will & testament And this I first being Penitent & Sorry from the bottom of my heart for all my sins past Most humbly begging Gods forgiveness and Remission of the same through the Merits of my Dear Redeemer & only Saviour Jesus Christ I Commit my Soul into the hands of Almighty God my Saviour & only Redeemer through the Merits of whom Death & Passion I hope to have full & perfect Remission & forgiveness of all my sins & My body to be Decently Entred by my Executors Hereafter Named in hope of a happy Resurrection at the last day & My Soul and body to Enter into perfect Joy & Felicity forevermore & for the settling and disposing of my Temporal Estate & such Goods and Chattels as it hath pleased God far above My Deserts to bestow upon me I Do order give & Dispose as followeth that is to say first all those Debts & Duties as I owe in Right or Conscience to any person whatsoever shall well and truly Contented and Paid

one Negro fellow Named Peter Called Great Peter Also I Give & Bequeath unto
unto my Grand Daughter Ruth Abram Robinson (Daughter one Negro fellow 600, &
one Child Catey one bed & furniture & one Cow &c. also I Give & Bequeath unto Robert Robinson
little Peter & Negro Wench Catey Also I Give unto James Mitchell fifty Acres of Land of the upper side
of the Branch whereon he lives Also I Give & Bequeath unto Nathl. Robinson Negro wench Judy Also
I Give to my Grand Daughter Susanna Robinson one Negro Child Called Sarah Also I Give to James Mitchell one Negro
Wench Called Silvany, Item it is my will that my Wife Mary Robinson have all the Rest of my Negroes
A one hoggs & Cattle also all my household gods with the Land she now lives on with all the Moveables
On the said plantation as long as she Mary Robinson doth live & after her Decease it is my will
that the Land & Every thing there is there should be sold & Equally Divided Between my seven
Children first Sarah John Nicholas Nathaniel Francis Mark Robert, Now the Executors whom
I do ordain and appoint is Edward Robinson Miles William & Charles Eaton to see this my will
Executed & fully performed In Witness whereof I have fixed my Seal and set my hand
