Imprimis, I give unto my well beloved wife Elizabeth her Choice of all my howe flesh & leather horse snare or holding and two cows and calves and her Choice of one fether Bed and furniture and such household stuff and provisions as she shall think fitt to keep and Durin a her natural life I lend her the use & Profit of my negro woman Cloe and my Dwelling Plantation and After my wife Decease the negro woman I allow to go with my son Little to be any one of my Children as they shall think proper to take her to go to work for the Maintainance of the said plantation till she be dead my son Hezekiah after my Wife Decease and my son Jacob after my wife's death it to work it I take the profits of it in the life time except my Dwelling Plantation but if my said son Hezekiah Utley should die Without Lawfull Issue then for the said land to be sold and the money Divided Among all my Vons and Daughters or if Decease the representatives of any one of them the Inherit their parentall part and if the said Hezekiah hath any Lawfull Issue then the said Land to him and to his Heirs and Assigns for ever also one Cow and calf and my feather bed and furniture, and all the rest of my Estate I desire may be Divided among all my Children at the Discretion of my son Jacob Utley and Hardy Sanders either by lot or sale or part of both and if any of my Children should be Dead for their Children or Child whether Born or In Ventre sa Maria to Inherit its parentall part My said Children as to have this Division is by name John Utley, William Utley, Jacob Utley, Epham Utley, David Utley, Hezekiah Utley, Littleton Utley, Lucy Sanders, Cynthia Meak and I do Nominate and Appoint the Above said Jacob Utley and Hardy Sanders to be my only Executors of this my last will and Testament Declaring this to be my last will and Testament in Witnes whereof I the said William Utley Senr. have hereunto set my hand and Affixed my Seal this twenty third day of December in the Year of Christ one thousand seven hundred and Eighty

son Hezekiah after my Wifes Decease all my land except my Dwelling
it is to work it or take the profits of it & after my wifes Decease my Dwelling
Plantation but if my son Hezekiah Utley should die Without Lawful
Issue then for the said land to be sold and the money Divided Among all my
Sons and Daughters or if Decease the representatives of any one of them to
Inherit their parential part and if the said Hezekiah hath any Lawfull Issue
then the said Land to him and to his heirs and assigns for ever also one cow
and calf and my feather bed and furnitures and all the rest of my Estate I
desire may be Divided among all my Children at the Discretion of my
son Jacob Utley and Hardy Sanders either by lot or sale or part of both and if
any of my Children should be Dead for their Children or Child whithers
Born or in Venesia Maria to Inherit its parential part My said Children
