1st I will give & devise unto such of the children of my deceased Daughter Nancy Briant as may be living at my death One hundred Dollars each to be paid in property at valuation as they arrive at lawful age or may marry To all but Wm. T. Briant who shall receive no part with the other children of my deceased Daughter Nancy Briant. exclusive of what I may give them in my life time:--

2nd I will give & devise to my Daughter Lydia Sparks at my Death One negro boy named Isaac to her & the lawful heirs of her body forever. exclusive of what I may give her in my----life time-----

3rd I will give & devise unto my Son Dum John Tolleson Five hundred Dollars to be paid to him at the pleasure of my executors.-----

4th I will give & devise unto my Daughter Levicey Kirby to her & her heirs forever One negro Man named Dick also Seven Hundred Dollars to be paid in property at my death at valuation exclusive of what I may give her in my life time.-----

5th I will give & devise unto such of the children of my Daughter Anny Gofsett^s may have living at my Death One hundred Dollars each to be paid in property at valuation as they arrive at lawful age or may Marry exclusive of what I may give her or them in my life time.

6th I will give & devise unto my Son Muse Tolleson & his heirs forever one negro man named Cooper & Seven Hundred Dollars to be paid in property at valuation exclusive of what I may give him in my life time:-----

7th I will give & devise unto my Son Ely Tolleson & his heirs forever Five hundred Dollars to be paid in property at valuation at my death exclusive of what I may give him in my life time.,.,

& his heirs forever

8th I will give & Devise unto my Son Stephen Tolleson ^{one} negro boy named Dazo also Seven hundred Dollars to be paid in property at valuation at my Death exclusive of what I may give him in my life time,,

9th I will give & devise unto Berriman Quinn Son of my Daughter Ity Quinn five Dollars at my death to be paid in property at valuation exclusive of what I have give his Mother & I never intend giving her any more:-----

10th I will ~~give~~ Order that all the rest residue & remainder of my estate both real & personal of what nature or kind Soever & every part thereof be Sold at public Sale & that out of the moneys arising from S^d Sale all my just debts funeral expences charges of proving this my will & ~~Testament~~ legacies herein made shall be paid the remainder of money arising from S^d Sale I will & devise unto my Sons Muse Tolleson & Stephen Tolleson to be equally divided between ~~of~~ them to have & to hold the Same to them & their heirs forever,

Neverthelefs all the property mention^d in this Will Shall be divided according To the will If not Sold or disposed of in my life time & If Sold or disposed of the Sale Shall be good-----

And I do hereby Nominate Constitute & appoint My Sons ^{Stephen Tolleson} Muse Tolleson ^{James Tolleson} & Birdsong Tolleson also my friend Abner Benson executors of this my last will & Testament hereby revoking & making void all former Wills & Testaments at any time heretofore by me made & do declare this to be my last Will & Testament I witness whereof I have hereunto Set my hand & Seal this Twenty fourth day of July in the Year of our Lord Eighteen Hundred & Twenty
