STATE OF SOUTH CAROLINA

IN THE NAME OF GOD AMEN-----I Daniel Sturges of the State of South Carolina & county of York Being weak of body, but of perfect mind and memory--Thankes be to my god for the Same-- Calling to my mind that I must leave this world for it is appointed once for all men to die--I Do make & ordain this my Last will & testament--That princable & first of all, I recommend my Soul to god who give it me--And my body to the Earth to be buried in a desant And Christain lick manner at the desecration of my Exct'rs hereafter mentioned And as for my worldly Estate that god haith blised me with--I give demise--and despose of in the following manner and form--than this is my will that All my Just debts together with my funarel Expences, be first paid by my Ex'trs. Than it is my will and desire to give unto my well beloved wife Jeain Sturges All my Estate real & personal to Viz the Land I now Live on & all my personel Estate Such as my horses cows Sheep hoggs and houshold furnater Such as beds bead Cloths potts putter Dressur and furnater and all the iron Tools belonging to the plantation &c, &c----- Likewise it is my desire That my Wife have all the above mentioned artickels during hir remaining a Widdow--And I do appoint my Two Sons To Viz. Leban & John Sturges to be gardains of my hold Estate during my wifes Lifetime--And after my wife's Decease it is my will & desire that Leaben Sturges my oldest son have all the Lands & improvements on the South Side of the S'd waggon road begining at the mouth of the Springbrnch & to run a Strait line to the S'd waggon road--and it is my Desire and will that my son Leaben do make his brother Daniel Eaquel to himself on the north Side of s'd road, that is in building of houses & planting of frute trees &c. And it is my will that Leabon my oldest Son (After the Land I now live on is paid for)

do pay unto John Sturges my third Son four^{pounds} Sterling a year for five years in Country produce wheat at three Shillings corn at two oats at two &c--Lickwise it is my will and I do desire that all my children more Espacialy my Daughter Marey have free asess to my house I now live in As thier homes During thier Leading a Single Life--It is my will & desire that my forth Son Josuah Shall have the one half of the profetts arising from my Boat as She now Stands to gether with one acer of Land on the South End Of Punchs Landing--with timber and fier wood to support the Same during the rining of s'd boat and no Longer--and if Josuah Sturges Should despose of s'd boat out of the family it Shall Emedatly desend Unto Daniel Sturges with all the obove mentioned primices Item I give and Bequeth unto the above mentioned Josuah Sturges one feather bead & its Furnather to him to be at his mothers decease--Lickwise it is my will to give and bequeath unto my son Daniel all the Land Lying on the north Side of the waggon road begining at the mouth of the Spring branch thence a stright line Unto the waggon road thence alongst s'd road unto the outside Line of s'd tract of land About a course of S'o & be W't And I do will that Daniel my son do pay unto Josuah the Sum of twenty pounds for the Space of five years--that is At the reat of four pound pr Anum--in country produce wheat at three Shilings corn at two oats at two &c. Item I give unto my Son James Armstrong Sturges one new Chest-----Item I give unto My daughter Marey Sturges one negroe wench named roase which Marey is to have during hir Life time and at hir death s'd weanch is to desend to my Son daniel Sturges and his Lawfull heirs of his body bgotton for Ever--Lickwise I give unto my daughter one feather bead & bead Clothes Lickwise unto my Daughter marey one mare of bay collar--and hir mothers Saddle at the mothers Decease one cow & calf at the day of hir marrag a live and good one new putter dish & three plates--Lickwise over and above what I have willd To my Sons to Viz. Leabon one feather bead & Clothes to Daniel one dito That I now make use of myself--Lickwise all the

or shall come to the hands possession or Knowledge of
the said Daniel Sturge or into the hands or possessions
of any other person or persons for him and the same so
Made do Exhibit or cause to be Exhibited into the Ordinarys
Office of this district at or before the 2^d day of Sept^r next
Next Ensuing and the same ~~so made~~ do Exhibit Goods
Chattels and Credits and all the other the goods Chattels and Credits
of the said deceased at the time of his death which at
Any time Hereafter shall come to the hands or possession
of the said Daniel Sturge or into the hands and possession of
