York District & State above named being weak in body but of perfect
mind, memory and understanding do make this my last will and testa-
ment in the following form. I recommend my soul to god who gave it
and my body to be buried in a decent manner at the discretion of
my Executors. And as touching such wordly Estate wherewithit has
pleased god to bless me. I give devise and bequeath as follows
that is to say. I give, devise and bequeath unto my daughter Rachal
Love a Negro woman named Caty and her childrn, a negro boy named
ned. my Sorrel horse with a ball face a Saddle and bridle also her
bed or beds & furniture. I give devise & bequeath to my daughter
Mary Meek a negro boy named Henry and a negro girl named Caty who
is now with her. To my Daughter Nancy Love. I give devise & be-
queath a negro girl named Eliza and a boy named Isom, a horse
worth seventy or seventy five dollars, a Saddle & bridle two beds
and furniture, household & kitchen furniture equal to what my daug-
hter Mary got. To my Daughter Margaret Love I give, devise & be-
queath three negroes Ben, Lyda, & Cretta A horse saddle & bridle
and household & kitchen furniture two beds & furntiure equal to
Nancy. To my daughter Elizabeth Wallace. I give, devise & bequeath,
two negroes Cenia & Charlotte, a two year old Sorrel mare, Sad-
dle & bridle two beds & furniture; household & Kitchen furniture
equal to Nancy. To my daughter Emma I give devise and bequeath a
negro woman Tilly & her two children and horse, Saddle & bridle;
household & Kitchen furniture two beds & furniture, equal to my
daughter Nancy. ^{To my daughter Elener} I give & bequeath three negroes; Harriott, Elve
and young Adam, a horse, Saddle, & bridle, household & Kitchen

furniture, two beds & furniture equal to my daughter Nancy- To my Son Arthur Love I give & bequeath two negroes boys, Tholly and Peter, a horse and Saddle & bridle, household and Kitchen furniture, a bed & furniture equal to my daughter Nancy. To my Son Andrew Franklin Love I give & bequeath three negroes Simman, Lewis and old Adam, a horse, Saddle & bridle, a bed & furniture household & Kitchen furniture equal to my daughter Nancy--- To my daughters Rachel, Nancy, Margaret, Elizabeth, Emy, Elener, and my two sons Arthur & Andrew Franklin Love, I give & bequeath a cow & calf To my two Sons Arthur And Andrew Franklin Love I give & devise my lands to be equally divided between them in Such manner & form as to give each of them a portion of meadow ground and also according to the quantity & quality of the said lands and Improvements, to them and their heirs forever. and Should either of my unmarried children die without a heir or will then I will that their part of my Estate should be equally divided between my six youngest daughters, my daughter Rachel and my two youngest sons. I will that two hundred acres of land which I owned in Livingston County Kentucky be sold whenever my executors think proper to sell it and the money be equally divided amongst all my children. I also will that all my personal Estate unwilled be sold and after paying my just debts and all necessary expenses towards settling my Estate, also one hundred & fifty dollars to my Nephew Bass, Methodist preacher, be divided equally amongst my six youngest daughters, my daughter Rachel and my two youngest sons Arthur & Andrew Franklin Love- It is also my will & desire that my family should live together at the plantation I now reside on and that my household & Kitchen furniture & so much of my stock and farming utensils be reserved as my Executors may think proper for the support of my family so long as they live together and the negroes willed to my four youngest daughters, my daughter Rachel & my two youngest sons be worked on the plantation or hired as my executors may think proper for each of their support while living together and so much of the land which is cleared that is necessary for the negroes to work and the balance if any to be rented for the

the Support of my unmarried children And I do hereby nominate
constitute and appoint my Son James M. Love and Dr. J. S. Bratton
Executors of this my last will and testament and also Guardians
to my four youngest daughters and two youngest sons, hereby re-
voking disannulling and disallowing all former wills by me made
ratifying & declaring this and no other to be my last will & testi-
ment In Witness whereof I the said Robert Love have hereunto set
my hand & seal this 29th day of November one thousand eight hund-
red and twenty Seven -- The negro Girl to Mary Week & two beds
to the other daughters and the word her was interlined before
signing Signed Sealed published and
declared by the said Robert Love to be his
last will & testament in the presence of us Robt. Love(L.S.)
who have witnessed the same at his request and
in his presence
