Secondly That all my just debts is to be paid out of my Estate And as for the rest of my property I Give & Bequeath it as followeth

Item I Give & Bequeath unto my son William Barnett all and singular my Lands & Tenements Not otherwise disposed of both the plantation that I now live on and the part of the Land that the said William Barnett now lives on with all the appertanances thereunto Belonging to him & his heirs forever as their property and to be at their disposal & I also give unto my son William Barnett my Roamed Mare & colts as his property and to ~~be~~ delivered up to him as soon as circumstances suits the Executor to deliver him up the Land and Mare.

Item I Give & Bequeath unto my son Alexander Barnett my Negroe Man named Will at my decease

Item I Give & Bequeath unto my daughter Mary Clinton & her Husband Joseph Clinton my Negroe or Yellow coloured Girl named Lavina to them & their heirs forever.

Item I Give & Bequeath Scintha M. Carter & her Husband Robert M. Carter my Negroe

Woman named Ann to them & their Heirs forever.
 And the Negro Woman Ann is to get the best Bed
 and Furniture belonging to it as her property.
 I desire that all my other is to be sold either
 before my decease or after it & Whatever Remains
 after all debts and demands is paid & satisfied
 is to be equally divided amongst my four Children
 or their Heirs forever Alexander Barnett Mary Chinton
 William Barnett & Scinthia M. Carter in Money Notes
 or property as they & the Executors can agree.
 I do also Constitute my son Alexander Barnett
 & my son-in-law Robert M. Carter Executors of this
 my last Will & Testament & disannul & Revoke
