The and the sd Sophia Cole must pay my son William Cole the sum of fifty dollars in Twelve months After my deceast and she the said S. C. must pay all just debts against my Estate and I also appoint the above mentioned Hynson Cole my sole Executor of thismy last will and Testament . witness whereof I have hereunto set my hand and seal this the thirteenth day of December one ousand eight hundred and thirty.
